



Lifetime Limited Warranty

Warranty Coverage

Winova Corporation, hereafter "Winova", warrants the original owner for Vinyl Siding Products (hereafter "Products") purchased hereunder Winova. This limited lifetime warranty (this "Warranty") covers Products free from manufacturing defects and subject to the conditions below. This warranty is against excessive board material colour fading, rotting, rusting, bubbling and blistering installed in Canada or United States of America. The lifetime warranty period offered for Winova Products is only available to the original, individual homeowners, and only if applied to a single-family home. All other structures and property owners (e.g. corporations, governmental agencies, partnerships, trusts, homeowner associations, cooperative housing arrangements, religious organizations, schools, condominiums, town-homes, apartment buildings, duplex, house of worship, and any other type of building or premises not owned by individual homeowners), including subsequent property owners (see Transferability section), are limited to a prorated 50 year warranty. The original property owner of a single-family home receives %100 non-prorated coverage. Subsequent owners and others (as described in this section) are covered by a -50 year prorated warranty as detailed here.

Should any Products be determined by Winova to have manufacturing defects, at the option of Winova, such Products will be replaced via Winova. The faulty Product should be returned to Winova facility or the Winova retailer/distributor where the Products were originally purchased. The degree of colour fading and all the manufacturing defects under the terms of this warranty will be evaluated by Winova, who will be the sole judge of what is considered reasonable or excessive discoloration.

From time to time Winova manufactures new Products, patterns, and colours, revises Products, and occasionally discontinues Products. Hence, the replacement of the Winova materials might not be an exact match of the original installed materials. At the discretion of Winova, equivalent replacement Products may be supplied.

Transferability Provisions

This warranty remains in effect for as long as the owner(s) of the property to which the Products were originally applied [the "Original Property Owner(s)"] continues to live in and to own the property. In the event that there is more than one Original Property owner, this warranty will remain in effect as long as one of the Original Property Owners is living and owns an interest in the property. Upon change in ownership, this warranty may be transferred to the new owner(s) ("Subsequent Transferee(s)") as a period mentioned within this Warranty, limited non-prorated warranty beginning from the date of original installation of Products. Upon transfer fade shall be covered as set forth in the Fade Protection Plan.

Limitations to Warranty

Winova does not warranty damage arising from improper handling, installation, or maintenance, not in compliance with Winova guidelines. All installation instructions must be followed without exception.

Winova does not warranty damage arising from abuse, exposure to harmful chemicals, or exposure to localized heat sources such as fireplaces, bar-beques, or space heaters.

Winova does not warranty damage arising from extreme forces such as fire, earthquakes, storms, hail, acts of nature, acts of war, and acts of terrorism.

Owner to submit warranty claim within thirty (30) days of discovery of Product defect, or the warranty is void.

Fade Protection Plan

Winova siding is not warranted against discoloration or other damage caused by air pollution, exposure to harmful chemicals, or normal weathering.

Normal weathering is defined as exposure to sunlight and extremes of weather and atmosphere which will cause any coloured surface to gradually fade, chalk, or accumulate dirt or stains. The severity of any condition depends on the geographic location of the building, the cleanliness of the air in the area, and many other influences over which Winova has no control.

Winova will warrant colour fade for 12 years, for the purposes of this warranty, excessive fading is defined as a loss of colour, after cleaning with a recommended solution, in excess of a Delta E of 4 colour unit accordance with testing results performed under ASTM D2244.

Hail Protection Plan

Winova Products, hereby provides a limited warranty on damaged by hail, provided that such hail damage is not covered by a homeowner's policy, or other insurance coverage.

If such hail damage is not covered by insurance, then Winova will provide material for replacement of the damaged siding. The homeowner shall be responsible for all labour and freight costs, and other expenses incurred in the removal or replacement of damaged Products. Proof of insurance required.

Limitations to Liability

Winova will not be liable for any consequential, incidental, special, or indirect losses.
